You explained to me that the final date for submissions was already passed, but that you could place my request before the Inspector who would decide if I could submit those documents.

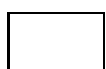
Regrettably, I have still not been provided with every last relevant statistic (which means that I cannot currently provide fully accurate and up to date figures).

I thank you for your assistance in this matter.

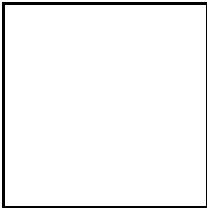
