I've not added this to Uniform or IDOX yet because I'm just too new but am emailing comments in the first instance - as you needed them ASAP:

On 12th April 2022, comments from WRS on behalf of the Environmental Protection Team included a request for the Desk Study for the application.

The Phase 1 Preliminary Risk Assessment(Desk Study) at South Farm, Wickwar by Clarkebond dated 02/04/20 (ref: B05313-CLK-00-XX-RP-GE-0001) has now been submitted.

From reviewing the desk study, it has been noted that asbestos was identified as a contaminant of concern but does not appear to have been included within the analysis of the soil samples within the Phase 2 Ground Investigation report.

Therefore, care should be taken, particularly in the vicinity of the farm, the areas of potentially backfilled ponds and any made ground across site for potential asbestos.

Otherwise, we are satisfied that the site investigation and conclusions are suitable for this application site.
