Hi Liz and Charmian,

Please see below the breakdown of costs for the work required at Lower Woods.

- £20,000 for staff time which will be spread over three years to oversee the works and undertake habitat creation with volunteers and contractors
- £25,000 for fencing, and where relevant, access infrastructure by contractors to manage visitor flows
- £40,000 which will be spread over two years for tree work to manage visitor safety in areas with substantially increased foot traffic
- £10,000 for signage to inform visitors about the vulnerable habitats on site and manage the follow of visitors through it
- £5,000 for tools and materials for habitat creation such as brush windrow barriers, scrub planting and fencing

In response to the question about a sum for us not to object the answer is no. No figure can truly compensate for a permanent change in visitor disturbance factors impacting on sensitive site features.
