

- FYI I have done some words about the Cotswold Beechwoods:
- 5.0 The Appellant has proposed their contribution based on the Cotswold Beechwoods SAC, which is not considered comparable. The Cotswold Beechwoods has a specific zone of influence, within which the scale of anticipated housing growth has been identified. The extent of mitigation for the area has been identified and costed, there are multiple schemes contributing to a 'pot' that will provide much wider mitigation measures for the SAC, known as a SAMM payment (Strategic Access Management and Monitoring).
- 5.1 In addition to that payment, every development of 50 dwellings or more is required to provide onsite Strategic Areas of Natural Greenspace. Whilst green space is provided on site, it would not meet the criteria for SANG which is usually made up of much larger areas of space, circa 15ha minimum. In those instances, a contribution towards off-site SANG is sought. In those instances an additional contribution of £480 per dwelling, is sought. This scheme is set out in the Cotswold Beechwoods Mitigation Strategy at Appendix \*\*.
- 5.2 Essentially the £34,740.00 proposed contribution equates to a SAMM contribution of £193 per dwelling. If the Appellant were to correctly follow the principles of the Cotswold Beechwood's strategy, an additional payment of £480 per dwelling would be payable, equating to £673 per dwelling.
- 5.3 As there is no such wider mitigation strategy associated with Lower Woods, there is a need to ensure appropriate mitigation is in place to preserve the SSSI for all future visitors, accordingly, the requested £555.55 per dwelling is considered appropriate.

I'm so sorry for the slow reply. I don't work on Wednesdays and have had a hectic morning!

We have had a response from EDP, who have declined to offer additional funds to support meaningful mitigation at Lower Woods. They have given a few reasons for this, which we do not see as sound. For example, their justification for the funds offered are based on the Cotswold Beechwood SAC Mitigation Strategy. We can understand why, in the absence of a mitigation strategy for Lower Woods, they would draw on this as a starting point. However, we have provided them with context around the work that will be required to help mitigate the additional pressure, as well as address the additional safety concerns we have over the high levels of ash dieback, so they should now be taking a more site-specific approach.

We will be replying in full to EDP later on today. We are also reaching out to NE to let them know that as the offer currently stands, we will be unable to carry out appropriate mitigation and Lower Woods will most certainly be at risk of recreational impact.

We will continue to keep you in the loop.

Hi Charmian,

I hope you are well. I have just returned to GWT from Maternity Leave and have picked this up from Meyrick and Juliet.

We have had a chat internally about the offer of s106 funds to support the additional pressures and are all in agreement that the £34,740 will be nowhere near enough to do the work required to help mitigate the impact of the additional footfall and pressure in Lower Woods. The work needed includes:

- Tree safety- With the location of the development being towards the south of the woodland it will increase the footfall in this area of the wood. Things we will need to do because of this: Reassess usage zones- based around footfall in an area, this helps inform what remedial action we might take on tree safety. If an area increases (which is highly likely) then it will increase the amount of work we need to do. With Ash dieback being a big problem in lower woods, we will need to address a much larger area than we do currently. This is heavily weather dependent due to Lower woods geology and topography, plus specialist with the team we require to do it.
- Entrance and exit ways- We will need to review these and improve access ways. This should involve:
  - Gates- these will need assessing and replacing- some areas which are boggy might need reviewing to stop paths from expanding due to people trying not to get muddy.
  - Signage- It would be good to have new signage created informing people about why lower woods is important and why it needs protecting, how we want people to behave. Just to give one example, there is a meadow just off Horwood Lane (which would be the most likely route that residents of the proposed development would take to access Lower Woods) which is incredibly diverse (see image attached) and would really need efforts to protect.
- Habitat creation in other areas of the wood to mitigate for the additional disturbance.
- Staff time- In order to plan this work, assess what needs doing, appoint contractors, install signage and gates. We would need to cover as much of our costs as possible.

It would take us a bit longer to figure out roughly how much this would cost but we're probably looking in the £100k+ region.

I am just about to get back to EDP listing the points above but wanted to let you know our thoughts ASAP. We will let you know how EDP respond.

Also very happy to have a chat if that would be helpful.

Dear, Ms Walker

Thank your for consulting us on the amendments to the outline application P22/01300/O The developers environmental consultants EDP have clearly looked at the ecological concerns expressed by GWT, Natural England and others, and, within the confines of the application site have tried to address them. What they have suggested in terms POS and its management is appreciated, and a move in the right direction.

Not withstanding this, no matter how attractive the application site is made to residents, there will still be a desire to seek out more visually and ecologically interesting landscapes in the immediate locality. EDP make much of the immediate connections the site provides to the wider PROW network, and whilst we accept this is available, the land to the west of application site is generally flat, open, arable and ecologically and visually uninteresting. This is in stark contrast to the land to the immediate west of Wickwar (including Lower woods) which is undulating, intimate, wooded and ecologically very diverse. This will inevitably draw people to the site with the resulting degradation of the habitat.

As a Trust we understand that people have a desire and a right to visit and experience wild spaces, indeed our strategy is all about re-connecting people with wildlife, however, that has to be managed in a manner that does not destroy the very asset people want to visit.

There are mitigating works and processes that could be bought to play 'off site' that could do much to allow the development to go ahead without compromising the integrity and ecological value of lower woods. Mitigation works both soft (education) and hard (infrastructure improvements) do of course do come at cost and it does seem reasonable that the development rather that GWT - the owner of Lower Woods bares the substantial burden of this. We maintain our objection therefore unless the development through a Unilateral undertaking or by whatever means can be agreed.

If minded to consent then this should be conditioned such that the ecological management plan is implemented in full, and if the above cannot be achieved that the developers at least enter into negotiations with GWT on how best to manage increased visitor pressure on Lower Woods.
