






Documents	Steps to view Documents






application boundary

This site is an allocation in the Local Plan and also has outline planning permission. The outline application for most of the allocated site is for up to 99 hectares of land including residential development of up to 2550 dwellings approved in 2013. A number of parcels are currently being built out, and a number have recently received RM consent.

This entry relates to the remaining balance of outline application for 201 units. As outlined in Annex 2 of the 2019 National Planning Policy Framework, paragraph b, this site will require evidence to demonstrate 201 units are deliverable within 5 years and therefore.

Parcels 19, 27b, 29, 30a and 30b have not yet been the subject of RM applications but are all in ownership of volume housebuilders currently building out other reserved matters applications, associated with this allocation and outline permission. There are no known outstanding viability or land ownership issues and all infrastructure has been planned for.

Given that there is a proven track record of delivery at Lyde Green the council considers there are no reason why the units in question will not be delivered within the next 5 years.
